**CDC Senior Consultant Whitaker Wright** held a public hearing to discuss the 2025 CDBG eligible programs. Mr. Wright stated Jackson County is eligible for the Allocation Program, but will not know the amount until probably April. Eligible competitive grants are: Neighborhood Revitalization Grant Program (\$750,000), Critical Infrastructure (\$500,000), Economic Development Infrastructure Program, as well as others. The ACS LMI data (Low-Moderate Income) are not accurate in non-urban areas. Mr. Wright stated that you have to have 5000 residents to be called a city.

**CDC Senior Consultant Whitaker Wright** then held a bid opening @ 10:31 a.m. regarding the 2023 CDBG City of Wellston Blamer Park Project. There were two bids submitted: Jackson Brothers Construction, with a proposed bid of \$75,000.00 and Stockmeister Enterprises with a proposed bid of \$135,296.00. Both of these bids were over the Engineer's estimate of \$50,500.00 and even with the 20% threshold, it would make it \$60,600. It will be reviewed by the Engineer, and most likely, have to be rebid.
